

ORDINANCE NO 27: An Ordinance to provide for licensing the sale of intoxicating and spiritous liquors within the village of Hokah Houston County, State of Minnesota and to prescribe the punishment for the sale thereof without such license.

The President and Trustees of the village of Hokah do ordain as follows.

SECTION 1.

The trustees of the village of Hokah may grant license for the sale of intoxicating spiritous vinous fermented and malt liquors within the corporate limits of said village to such persons as the said Trustees in their discrestion may see fit upon complying with the conditions hereinafter mentioned.

SECTION 2.

Any person applying for license to sell intoxicating spiritous vinous fermented and malt liquors within said village shall before the same is issued to him satisfy the said Trustees that he is a person over 21 years of age that he will keep an orderly house and comply with the provisions of this ordinance.

SECTION 3.

Every such person shall before license is issued to him pay to the village Treasurer the sum of \$125.00 dollars per annum payable semiannually in advance and shall file a bond with the village recorder with two or more sureties to be approved by the board of Trustees in the penal sum of Five Hundred dollars which bond shall run to the village of Hokah and the conditions thereof shall be that the person so licensed shall not sell or otherwise dispose of any intoxicating spiritous vinous fermented or malt liquors in any quantity whatsoever on the Sabbath or on any general or special election day that he will keep a quiet and orderly house and not permit gambling with cards or any other device for money or the representative of money in the house or place of business of such person and that he will not sell give barter furnish or dispose of in any manner either directly or indirectly any spiritous vinous

fermented malt or intoxicating liquors in any quantity whatsoever to any pupil or student in any pupil or student in any public school, seminary, or other institution of learning who is under 21 years of age in said Houston County or to any minor person or habitual drunkard.

SECTION 4.

Any person who shall sell any intoxicating, spiritous vinous fermented or malt liquors within said corporate limits of the village of Hokah under any pretext or in any manner from which an intention to wade the provisions of this ordinance appears or who shall not have obtained a license as herein before provided shall for every offense be fined a sum not less than twenty-five nor more than one hundred dollars and in default of the payment thereof together with the cost of the prosecution may be imprisoned in the common jail of said Houston county for a period not less than ten nor more than ninety days.

SECTION 5.

The trustees shall have the power to revoke any license granted by them whenever they are satisfied that the party so licensed has violated any of the provisions of this ordinance.

SECTION 6.

All of that ordinance entitled an ordinance to prohibit and punish the sale of intoxicating and spiritous liquors within the village of Hokah passed and filed Aug. 24, 1878 and all other ordinances in conflict with this ordinance are hereby repealed

SECTION 7.

This ordinance shall take effect and be in force from and offer its passage adopted passed signed and sealed this 12th day of April 1879.
