

ORDINANCE NO. 76

AN ORDINANCE AMENDING ORDINANCE 56 OF THE VILLAGE OF HOKAH, HOUTON COUNTY, MINNESOTA, REGULATING THE USE OF PUBLIC AND PRIVATE SEWERS AND DRAINS, PRIVATE SEWAGE DISPOSAL, THE INSTALLATION IN CONNECTION WITH THE BUILDING OF SEWERS, AND THE DISCHARGE OF WATER AND WASTE INTO THE PUBLIC SEWER SYSTEMS, AND THE LICENSING OF SEWER LAYERS AND PLUMBERS AND PROVIDING PENALTIES FOR VIOLATION THEREOF IN THE VILLAGE OF HOKAH, HOUSTON COUNTY MINNESOTA

The Village Council of the Village of Hokah ordains:

I. Article XII of Ordinance no. 56 of the Village of Hokah is hereby repealed and Article XII shall hereby read and provide as follows:

A. There shall be payable to the Village of Hokah for the use of its public sanitary sewer systems a monthly charge based upon the following schedule: for all private residential hook-ups and connections, the monthly sum of \$2.00 per connection or hook-up.

B. For commercial establishments the monthly rate is accordance with the following schedule:

Class A-----	\$4.00	Class D-----	\$7.00
Class B-----	\$5.00	Class E-----	\$8.00
Class C-----	\$6.00		

C. (1) For purpose of this Ordinance, Class A shall be construed to include all churches and formally organized places of worship, lumber companies, implement companies, grocery stores, feed mills, hardware stores, and similar commercial establishments.

(2) Class B shall be construed to include all taverns, bars, tap-rooms, and restaurants.

(3) Class C shall be construed to include all schools, public and private, secondary, elementary or other.

(4) Class D shall be construed to include all garages, filling stations, and all firms involved in the business of servicing motor vehicles, including the repair and over-haul thereof.

(5) Class E shall be construed to include cheese factories, creameries, slaughterhouses, and commercial laundries, including self-service or other types of commercial laundries.

D. The charges for sanitary sewer service pursuant to the foregoing schedule shall be billed twice annually and payable on the 15<sup>th</sup> day of October and the 15<sup>th</sup> day or April of each succeeding year. There shall be payable a 10% penalty for all such charges 30 days or more in arrears, together with interest at the legal rate. The Village Council of the village of Hokah may by its resolution cause certification of the amount of arrearages in a given year together with penalty and interest to be transmitted to the Houston County Auditor to be payable with real estate taxed on the specific property or properties receiving such sanitary sewage service.

This Ordinance shall be effective October 1, 1972.
