

AN ORDINANCE to amend an Ordinance entitled “An Ordinance to amend an Ordinance entitled ‘An Ordinance to prohibit the selling or dealing in Vinous, Spirituous, Malt, fermented or intoxicating drinks.

THE PRESIDENT and Trustees of the Village of Hokah do ordain as follows.

SECTION 1.

That the Ordinance entitled “An Ordinance to amend an Ordinance entitled ‘An Ordinance to prohibit the selling or dealing in Vinous, Spirituous, malt, fermented or intoxicating drinks. Adopted by the President and Trustees of the Village of Hokah on the 15<sup>th</sup> day of April A. D. 1872 be and the same is hereby amended to read as follows.

SECTION 2.

Section One of Said Ordinance shall read, “No person shall sell, expose for sale, barter, furnish or give away within the Corporate limits of the Village of Hokah in any quantity any spirituous Vinous, or fermented and malt liquors without first having obtained a license so to do from the Trustees of Said Village and without first having executed and filed in the recorder's office a bond in the same of \$500.00 approved by Said Trustees, and conditioned in accordance with the laws of the State of Minnesota regulating the traffic in intoxicating liquors.

SECTION 3.

Section two of Said Ordinance shall read as follows no person licensed to deal in intoxicating liquors under Section two of this Ordinance shall at any time or in any manner either directly or indirectly within the Corporate limits of the Village of Hokah sell, give, barter furnish, or dispose of any spirituous, vinous fermented or Malt liquors to any minor person, pupil, student in any public school, seminary, academy, or other institutions of learning or any intemperate person, or habitual drunkard.

SECTION 4.

Section three of Said ordinance shall read as follows: Any person applying for a license to sell intoxicating liquors within the Village of Hokah shall before the same is issued pay to the Treasurer of Said Village the same of ninety (90.00) dollars, and shall, before the same is issued, execute and file a bond in the Recorder's Office, with two sufficient securities to be approved by the Trustees of Said Village, and conditioned according to Section two of Chapter 16 of the General Laws of the State of Minnesota, as the same is amended by “an act of the Legislature of the State of Minnesota, entitled “An Act to Amend Chapter Sixteen of the General Statutes relating to the sale of intoxicating liquors. Approved on the 4<sup>th</sup> day of March A.D. 1872; All licenses issued under Section one of this Ordinance shall be in force for the term of one year from and after the day of issuing the same and no longer provided that licenses may be issued for a term not exceeding one year nor less than six months, the applicant to pay for such license a sum of money which shall bear the same proportion to price of an annual license as the time for which the same is issued bears a full year.

SECTION 5.

Any person who violates any of the provisions of Section two of this Ordinance shall be punished by a fine of not less than twenty-five dollars, nor more than One Hundred dollars, and in default of payment of Said fine shall be imprisoned in the County Jail for a term not exceeding sixty days or until such fine is paid.

SECTION 6.

Any person who violats any of the provisions of Section three of this Ordinance shall be punished by a fine of not less than fifty dollars, nore more than one hundred dollars and is default of payment of Said fine shall be imprisoned in the county jail notless than thirty nor more than ninety days—

SECTION 7.

Any person who violates any of the conditions of his bond, which he has executed and filed pursuant to Section four of this Ordinance, shall in addition to other fines and penalties hereby imposed upon him by this Ordinance, be subject to have the license issured to him sworned and declared null and void; and any such violation will be deemed sufficient cause of such revocation—
